Application form for New Studios and Guests

July 19th, 20th & 21st AND October 4th, 5th & 6th

Deadline for application: January 14, 2019 BY 12 NOON.

Applications will be reviewed at the Jury Meeting on January 18, 2019

Studios: You must have an indoor studio/studio area located within the area of the studio tour. It must be large enough to accommodate the expected numbers of visitors, and be accessible with parking.

Guests: You do not have to live/work locally. But need to have a tent and display to set up at another studio location

Please list if there is a studio you would like to be a guest at.

Results of the jurying will be made known to applicants shortly after the meeting.

Membership Requirements: Studios and Guests

1. There are to be demonstrations during the Studio Tour if at all possible.
2. Show only your own work.
3. All members - studios and guests - must distribute brochures.
4. All studios are assigned jobs. Note: guests are **not** expected to do a job but are welcome to volunteer
5. After being juried in, studios are expected to attend all meetings, especially the January jury and general meeting. All members, both studios and guests are invited to the fall wrap-up meeting.
6. Total cost for Summer and Fall tours is \$285. One tour is \$210.
Payable by February 6, 2019 at general meeting.
7. All Studio Tour Members must submit, by the deadline, images of their work and text for the website www.madawaskastudiotour.com and for the Brochure when required.
8. Failure to abide by terms could result in review of membership.
9. Members (studios and guests) are not re-juried every year. Members are able to take sabbatical without re-jurying.
10. Guests are reviewed every year.
11. Serving of alcoholic beverages is absolutely prohibited. Any food or drink served at a studio is at the sole risk of that studio, and the Madawaska Valley Studio Tour or any of its other members cannot be held responsible for any possible resulting liability or illness or damages.
